  - Provide audited financial statements for the same period.
  - Include board resolutions/minutes authorizing submissions and any other MCA/regulatory filings required under NSP2025.
- Documentation to Submit:
  - Completed ROC forms for each year affected.
  - Audited financial statements for the same period.
  - Board resolutions or minutes authorizing submissions.
  - Any other MCA compliance certificates or filings requested by the Ministry.
- Submission Deadlines:
  - Deliver the complete compliance package to:
    - The National Federation, and
    - The Registrar of Companies, by: 15th September 2025.

## Governance and NSP2025 Recognition

- The Federation will consolidate all submissions and coordinate with the Ministry for recognition as a national game. The Federation's role is to facilitate compliance; liabilities or penalties arising from non-compliance remain governed by the federation's internal rules and statutory provisions.
- In the event of non-compliance or partial compliance, the Federation reserves the right to initiate governance actions necessary to wind down or adjust membership/directorship within Federation structures, up to and including termination of membership or issuance of No-Objection Certificates (NOC) in accordance with due process and governance documents.

## Consequences of Non-Compliance

- If the above documents are not submitted in full by the stated deadline, the Federation may initiate:
  - Governance actions to wind down the State Association's membership and directorship within Federation structures, and/or
  - Issuance of an NOC to members seeking to disengage or dissolve their association, in line with Federation rules and due process.
- Liability and Accountability: The Federation shall not be liable for any liabilities, penalties, or legal consequences arising from non-compliance or subsequent dissolution. The State Association shall indemnify the Federation to the fullest extent permitted by law.

## Request for Immediate Action

- Please treat this as the final notice and initiate the required ROC filings and compile audited statements without delay.
- If full compliance is not possible within the deadline, provide in writing a detailed plan for an orderly wind-down or dissolution in accordance with applicable governance documents and statutory procedures.
