Subject: Final Reminder – Temporary Hold on Membership Pending Mandatory Compliance under NSP2025

To: The Presidents / Chairpersons / Directors  
All Affiliated State Associations

Dear Stakeholders,

This is a follow-up notice to the previously issued Final Notice dated 04 September 2025 (Ref. No. ABFI-NTC-SA-05) regarding mandatory compliance under NSP2025 and ROC filing requirements. Despite prior communications, a number of associations have not submitted the required documentation. This notice serves to emphasize the status, deadlines, and consequences to ensure prompt resolution.

## Context and Current Status

- NSP2025 compliance remains a statutory and federation-policy requirement for national recognition.
- Outstanding items include ROC filings for the last three financial years, audited financial statements, and associated board resolutions or minutes authorizing submissions.
- Non-submission or incomplete submission continues to impact governance, finance, and national recognition processes.

## Immediate Action Required

1. Complete and submit the following by the deadline:
  - ROC filings for the last three financial years (with corresponding audited financial statements).
  - Board resolutions/minutes authorizing the ROC filings and financial submissions.
  - any additional MCA/NLP pending filings.
2. Provide formal confirmation of submission along with copies of filed documents to:
  - Federation: [aainballindia@gmail.com](mailto:aainballindia@gmail.com)
3. Ensure documentation adheres to NSP2025 guidelines and Federation governance requirements.

## Temporary Hold on Membership and Directorship

- Effective immediately, failure to submit the complete compliance package by 30 November 2025 will result in a temporary hold on the association's Federation membership and directorship rights.
- During this temporary hold period, the association will not be eligible to participate in Federation governance processes, endorsements, or related activities.
- The temporary hold will remain in force until full compliance is demonstrated and verified by the Federation.

## Permanent Barring and Further Action

- If, by 30 November 2025, an association remains non-compliant or provides inadequate reason without an approved remediation plan, the Federation reserves the right to:
  - Permanently bar the association from Federation membership and related governance engagements, and/or
  - Initiate dissolution or wind-down procedures in accordance with the Federation's by-laws and statutory procedures.
- Any liabilities, penalties, or legal consequences arising from non-compliance or dissolution will be the responsibility of the association, and the Federation will not be liable.

## Documentation and Verification

- Please ensure all documents are legible, properly signed, and stamped where applicable.
- Submit electronically to the federation email and provide hard copies as needed for record-keeping and audit trails.

## Plan for Non-Submission Scenarios

- Should it be impossible to meet the deadline, submit a written, detailed remediation plan outlining:
  - Reasons for non-submission
  - Step-by-step timeline to achieve full compliance
  - Interim controls and governance measures to minimize risk
  - Points of contact and escalation channels
- The Federation will review plans on a case-by-case basis and communicate decisions promptly.

## Governance and NSP2025 Recognition

- The Federation remains committed to compliance, governance integrity, and national recognition under NSP2025.
- Liabilities or penalties resulting from non-compliance are governed by internal rules and applicable statutory provisions.

## Request for Immediate Action

- Treat this as a final, formal reminder to initiate and complete the required ROC filings and audited statements without further delay.
- If you require assistance or clarification, contact the Secretariat.

We appreciate your urgent attention to this matter and your cooperation in maintaining the integrity and recognition of our federation.
